They are repainting inside the shelter and putting in a new HVAC unit. Since the establishment of the Humane Society Equine Division the Animal Control calls for equine have decrease significantly. They are currently short one Animal Control Officer.

Detention Center Reports - Jailer Bruce Todd.

Jailer Todd presented the quarterly report to the court. They currently have a HVAC unit that needs replacement. They are still looking at purchasing body scanners. A male Moral Reconation Therapy "MRT" class will soon be started. The "Rocket Docket" will be starting August 1 and that should help with the county inmate population.

Magistrate Berry made a motion to accept the Detention Center's quarterly report. Magistrate Tompkins seconded the motion. A voice vote was held, all approved and the motion carried.

County Sheriff's Monthly Report - Lt Anthony Willett

The Sheriff's monthly reports were presented to the court for acceptance.

Magistrate Southard made a motion to accept the Sheriff's monthly report into the record. Magistrate Starks seconded the motion. A voice vote was held, all approved and the motion carried.

County Clerk's Report - County Clerk Renesa Abner

Renesa presented the monthly and quarterly reports and turned a check over to the court for \$131,798.98 in excess fees for a total of \$190,626.38 remitted to the county this month.

Magistrate Puttman made a motion to accept the County Clerk's reports into the record. Magistrate Southard seconded the motion. A voice vote was held. All present voted in favor and the motion carried.

County Attorney's Report - County Attorney Steve Gold

Steve presented a report of payments dated July 25, 2023 and turned over \$11,057.58 in various checks to the court.

Magistrate Puttman made a motion to accept the County Attorney's payments into the record. Magistrate Tompkins seconded the motion. A voice vote was held. All present voted in favor and the motion carried.

Treasurers Annual Settlement/Statement - Brenda Rider

Treasurer Brenda Rider formally presented the annual settlement/annual year end statement for last fiscal year to the Fiscal Court as required by the state.

Motion was made by Magistrate Tompkins to accept the annual settlement, seconded by Magistrate Southard. A voice vote was held with all voting in favor and the motion carried

Good of the County

Judge Schneider said the County Engineer Nick Stallings is working with one of the solar farm companies with the issue of oversized and overweight trucks that may be using county road to transport some of the large and heavy equipment. Permit fees or bonding may be necessary to hold companies accountable. The Judge would like the court's permission to allow Nick to set any permit fees or bonds that may be necessary. Enforcement of the overweight issues will have to be worked out with the proper authorities.

Magistrate Tompkins made a motion to allow County Engineer Nick Stallings to set the appropriate parameters to include bonding amounts for the road involved. Magistrate Berry seconded the motion. Magistrate Southard asked if this would also apply to Boardwalk's pipeline being replaced throughout the county. Nick said the pipeline will be crossing 27 county roads. He has already met with company officials and most crossings will be bored. He would like any crossings that are open cut to be treated separately and bonded individually. A voice vote was held with all voting in favor. Motion carried.

<u>Mary Dunham</u> of GAIN (Getting Ahead Initiative Network) introduced two students currently going through the summer GAIN program. The group meets twice a week for 8 weeks. They were here today to observe the workings of local government and will also be attending the City Commissioner meeting later today.

Kenny Garrett explained they were given a grant by the Community Foundation of Western Kentucky to purchase a new drone for the EMA office. Because of the capabilities this drone will offer it will be very useful not only for the EMA office but also for law enforcement and emergency response agencies in Henderson County and neighboring counties. He introduced Dr. Chris Dockins the COO of Community Foundation of Western Kentucky. Dr. Dockins explained what the Community Foundation has done in Western Kentucky. She met Kenny & Jill at one of the Emergency Management Conferences and was impressed by the models they had been making to help the community. A check for \$15,689.70 was presented for the purchase of a new drone.

<u>Judge Schneider</u> said we budgeted \$700k for asphalt for this year. We will be amending \$400k into our asphalt budget from the Road Fund carryover. We will also be keeping our flex funds from KYTC so we are planning to spend over \$1 million in asphalt this year. Nick is in the process or working with the magistrates to develop a list of roads.

There being no further business to come before the court, Magistrate Tompkins made a motion to adjourn. Seconded by Magistrate Southard.
